

One Year In: Congressman Ciscomani Isn't Looking Out For Arizonans

Since being sworn into Congress in January 2023, Congressman Juan Ciscomani has voted against the well-being of his constituents.

Congressman Ciscomani Voted to Repeal Funding for the IRS to Go After Wealthy and Corporate Tax Cheats

Congressman Ciscomani opposed the Inflation Reduction Act, which passed Congress in 2022. One of the law's key provisions ensured that the ultra-wealthy and corporations pay their fair share in taxes. Congressman Ciscomani voted multiple times to protect wealthy and corporate tax cheats by rescinding this crucial funding from the IRS.

Congressman Ciscomani Voted To Raise Energy Costs for Arizonans

Congressman Ciscomani voted for legislation that would roll back rebates that help Arizonans afford energy-efficient appliances and tax credits for solar energy from the Inflation Reduction Act. He also voted to give billions in tax breaks to Big Oil and Gas companies while Arizonans continue to struggle with high prices for gas and utilities.

Congressman Ciscomani Voted To Limit Abortion Access

Congressman Ciscomani has dangerous views and a voting record that should alarm all Arizonans who seek an abortion. He voted to make it harder for veterans and active military to receive abortion care and he supports a bill that would prohibit Affordable Care Act health insurance plans from covering abortion, which could raise health care costs for Arizonans. Ciscomani also applauded the overturning of Roe v. Wade. Now, people who seek abortion in restrictive states have to seek care elsewhere, adding additional costs with travel and accommodations.

Congressman Ciscomani Voted To Cut Access to Social Security and Medicare, Which Would Impact Arizona's Seniors

In April, Congressman Ciscomani voted for the "Default on America" Act, which would have lengthened Social Security and Medicare assistance wait times for 1.5 million Arizona seniors and people with disabilities. In July, he voted again to cut access to Social Security and Medicare by supporting an appropriations bill that included a \$183 million cut for the Social Security Administration and a \$798 million cut for Centers for Medicare and Medicaid Administration.

Congressman Ciscomani Voted For Corporate Tax Breaks And Supports Extending A Tax Break For The Rich From The GOP Tax Scam

The 2017 GOP Tax Scam slashed the corporate tax rate and dramatically cut taxes for the rich and corporations, concentrating the benefits at the top and leaving millions of working families behind. Now, House Republicans are looking to extend many of those tax cuts that expire in 2025. Rep. Ciscomani has voted multiple times for corporate tax breaks and he already supports extending one of the GOP Tax Scam's costliest tax breaks for the rich. Extending those tax cuts would primarily benefit the ultra-rich and foreign investors and would increase the deficit – if the provisions are made permanent they would together cost over \$1 trillion.
